

Board of Selectmen Town Hall Hearing Room September 22, 2009 Regular Meeting

Sewering Project Update [G. Allaire, B. Howes & D. Young]

Represented by DPW Director George Allaire and David Young from CDM and Dr. Brian Howes SMAST. Dr. Howes presented a PowerPoint describing the Parker Rivers Estuaries Report. Mr. Sullivan asked about aggressive solutions which Dr. Howes suggested fixing the bridge would produce solutions almost immediately. Mr. Young updated the Board on the Nitrogen assessment and possible decreasing of sewering. He showed a master plan map on PowerPoint.

Ms. McAuliffe suggested that perhaps an applicant who is requesting consideration for the School Committee vacancy could possibly be placed on this Sub-Committee.

Ms. McAuliffe referenced an email from Board of Health Chair, Helen Shaw, regarding attendance and membership of the Board of Health. Mr. Snowden has missed 5 consecutive meetings this summer and his absence has affected the work progress and even meeting quorums at some instances. Ms. McAuliffe requested support from the Board of Selectmen in formally requesting resignation from Mr. Snowden due to the multiple consecutive

absences from the Board of Health. There was a 3-2 consensus a letter from the Chair of the Selectmen to request Mr. Snowden's resignation should be sent.
