

Board of Selectmen Town Hall Hearing Room April 12, 2011 Regular Meeting

The meeting was called to order at 7p.m. by Selectmen Erik Tolley. Selectmen present: Suzanne McAuliffe, Bud Groskopf, Tracy Post and Curt Sears. Also Attending: Acting Town Administrator Peter K. Johnson-Staub. The Pledge of Allegiance was led by Station Ave Elementary Students

Station Ave Elementary School Principal spoke to the Board about some new programs available to the students.

There was discussion on many different financing options. It was agreed that a 25/75 scenario be presented at the Public hearing for Phase One and possibly Phase Two.
