

Board of Selectmen Meeting Minutes January 13, 2015

The regular meeting was called to order at 7:00 p.m. in the Town Hall Hearing Room by Selectman Tracy Post. Selectmen present: Norm Holcomb, Jim Quirk, and Michael Stone. Also in attendance: Town Administrator, William Hinchey. The Board of Selectmen gave the Pledge of Allegiance.

Public Announcements & Comments

Andrea St. Germaine, Yarmouth Representative to the School Committee, provided an update on School activities.

Suzanne McAuliffe, Yarmouth Representative to the Barnstable County Assembly of Delegates, provided an update on Barnstable County issues (budget, Cape Light Compact, and the Agriculture Research project).

Barry Claman, representing residents of his neighborhood, commented on the fencing along the bike path.

Joyce Flynn, Representative for Cape Light Compact, provided an update.

Chief Fredrickson made comments and read short biographies for 3 new Yarmouth Police Officers to be sworn in: Conor Burnham, Ryan Brule, and Alexander Xiarhos. The 3 new officers were sworn in by Town Clerk, Phil Gaudet.

1. Public Hearing

Show-Cause Hearing – Longfellow's Pub

Licensing Chair, Mike Stone, read the public notice. Representatives from Longfellow's Pub, Janet McInerney and John Kevin Russo, were present for the hearing. The following witnesses were identified and sworn in by Selectman Stone: Chief Frederickson, Detective Carty, Officer Gibbons, Janet McInerney, and John Kevin Russo. Chief Fredrickson read the police report; the Board reviewed the police report and documents provided by Longfellow's Pub. The Board discussed the incident and asked questions of the Longfellow's Pub representatives. Ms. McInerney was asked if she had, in fact, served alcohol to an intoxicated person. She replied that she had.
