

Board of Selectmen Regular Meeting April 23, 2013

The regular meeting was called to order at 7:00p.m. in the Town Hall Hearing Room by Chairman Erik Tolley. Selectmen present: Curt Sears, Norm Holcomb, Jim Quirk and Tracy Post. Also Attending: Town Administrator William G. Hinchey. The Board of Selectmen gave the pledge of allegiance.

Public Announcements & Comments (Hearing Room)

Chief Frederickson spoke to the Board about the Boston Marathon bombing and manhunt for the suspects. Yarmouth police Officers who were deployed to assist the Boston Police were recognized.

Assistant DPW Director Rob Angell spoke to the Board about Yarmouth Pride Day scheduled for April 27th at Homer Park, 9am.

Steve Gavin, Yarmouth rep to CVEC and Joyce Flynn, Yarmouth rep to CLC spoke about public comments made to the Selectmen by Peter Kenney.

Vida Morris asked for clarification on the override explanation. She also spoke about a house bill being filed regarding regional school district budgeting. She questioned if Cleon Turner would be a co-sponsor. Mr. Hinchey described the proposed house bill and how it will not benefit or relate to the D-Y Regional District. The Bill does not address a district meeting in the event of a failed override.

The meeting was turned over to Licensing Chairman Sears.

Chairman Sears read the legal ad, application represented by John Hutchins. Mr. Hutchins briefly described the application for the mechanical Bull which he hopes will attract new customers and/or more business. Ted Dinsmore spoke about his safety concerns with the proposal and his opposition of the violence the proposal projects. Mr. Dave Robbins also spoke against the noise that he expects it to generate. Ms. Vida Morris spoke about last week's public hearing. Mr. Hutchins stated that the business closes at 9am and there is no alcohol on the premise that would be comparable to the examples the abutters spoke about. He feels the application is sensitive to the abutters private lives. Mr. Hutchins described the construction of the bull and rider safety features. Ms. Post asked how Mr. Hutchins planned for large group gatherings. Mr. Hutchins stated the hours of the operation will attract more families than any other group. Mr. Tolley expressed concern with increased noise levels. Mr. Quirk asked if there will be an attendant during operation. Mr. Hutchins stated that an operator/attendant is required and will be detailed at the bull location. Mr. Holcomb stated he would be more comfortable with the bull inside a building rather than inside a tent that is not enclosed. Ms. Post asked Chief Frederickson what options abutters have if they have a noise complaint. Chief Frederickson reminded the Board that a year ago they approved an inflatable water park that is closer to a residential area than this location. He did not know if this is a similar situation of supporting businesses being creative but he supported the proposal. Ms. Post stated that the recent passing of zoning bylaws to attract entertainment to Route 28 is exactly what this proposal before them is in spirit of. She is however sensitive with the neighbors' complaints and concerns and it needs to be incorporated within the license conditions.
