It is intended by this notice to inform the general public that the Town of Yarmouth intends to amend the CDBG PY2020 and CDBG-CV PY2019 Annual Action Plans as shown below.

Budget Revision: The budget revision is intended to place funds into activities which are expected to expend money in a timely manner. For the PY2019 CDBG-CV Program: Add \$30,000 to the Small Business Assistance activity and subtract \$30,000 from the Administration and Planning activity. For the PY2020 CDBG Program: Add \$90,000 to the Affordable Housing budget, subtract \$55,000 from the Job Retention and Creation budget, subtract \$10,000 from the Spot Blight Removal budget, and subtract \$25,000 from the Public Infrastructure budget.
