The purpose of this public hearing is to obtain the comments and the views of citizens, public agencies, community organizations, and other interested parties in Yarmouth on the CDBG One-Year Annual Action Plan for the Program Year 2021. The Program Year 2021 runs from July 1, 2021 to June 30, 2022.

Information obtained through this effort will be considered in the preparation of the One-Year Annual Action Plan, which is the planning and strategic document for the Town's Community Block Grant Program (CDBG). The CDBG Program is funded by the Department of Housing and Urban Development (HUD).

The anticipated funding amount for Town of Yarmouth CDBG Program Year 2021 is \$128,000.

The purpose of CDBG funds is to provide housing, economic opportunities and a suitable living environment for low and moderate income persons. The range of activities that may be taken by the CDBG Program include affordable housing, spot blight removal, economic development, job retention and creation, special business assistance, public facility improvements and public services. Other activities will be considered for eligibility.

Interested parties may submit comments for consideration in the preparation of the draft Plan at the public hearing.
